#### WHAT IS TRANSFERABILITY?

Transferability is the ability to transfer a commercial use development allotment (CDA) from one site (the sending site) to another site (the receiving site).

#### WHICH SITES ARE ELIGIBLE FOR TRANSFERABILITY?

Both the sending site and receiving site must be located in commercial land use districts. The sending site must be a site with a partial CDA (sites with full CDAs are not eligible to transfer their allotments). The receiving site can either be a site with a partial CDA or a site for which a CDA application was submitted prior to the 2005 random selection draw but for which no CDA was received.

## WHAT IS THE PROCESS FOR TRANSFERRING A PARTIAL COMMERCIAL USE DEVELOPMENT ALLOTMENT?

Prior to submitting an application form, you are encouraged to contact Town of Banff Planning and Development Department to confirm your eligibility. Once eligibility is confirmed, submit a completed application form. A development officer will review the form and you will be notified of the decision in writing within 60 days of your submittal date.

A Development Officer may refuse to accept an application for the transfer of a partial commercial use development allotment if, in the Development Officer's opinion, the application for transfer is not in conformity with the Land use Bylaw 31-3 and does not make adequate provision in respect of the regulations or guidelines of this Bylaw. A decision to refuse an application to transfer a partial commercial use development allotment may be appealed to Town Council.

## WHAT IS THE DEADLINE FOR TRANSFERRING A PARTIAL COMMERCIAL USE DEVELOPMENT ALLOTMENT?

An application to transfer a partial commercial use development allotment must be submitted at least 60 days prior to the first date after July 30, 2005 upon which a commercial use development allotment is made available for allocation, as determined by the Development Officer, or November 15, 2009 which ever date first occurs.

The Development Officer shall send a notice of the deadline to make an application to transfer a partial commercial use development allotment, at least 120 days prior to the date upon which a commercial use development allotment is to be made available for allocation to partial allotment holders and to those applicants who previously submitted an application for a commercial use development allotment but were unsuccessful in obtaining a commercial use development allotment.

If an application to transfer a partial commercial use development allotment is not submitted prior to the deadline specified in the development officer's notice, the partial commercial use development allotment may not be transferred and no subsequent application to transfer the partial commercial use development allotment will be accepted.

#### WHAT IS THE FEE FOR PROCESSING A CDA TRANSFER APPLICATION?

Application processing fees are outlined in the Development Processing Fees Schedule. These fees help the Town to partially recover the costs of reviewing, approving, and advertising Development Permits. Building permits have associated fees and vary depending on the estimated value of the proposed development. New buildings, additions, or renovations that result in the creation of new floor area are charged off-site levies in accordance with the Off-site Levies Bylaw. Off-site levies are used to pay for all or part of the capital cost of new or expanded sewer and water facilities. Other fees may apply. Contact Town of Banff Planning and Development staff for more information.
