Exceptions may be granted to residents with special needs, at the Town's discretion.</li> </ul>	Banff Resident: Lesser of 50% or \$500

Studded tires <i>(winter only)</i>	<ul style="list-style-type: none"> <li>- Receipts must be dated between Oct 1 and Mar 31</li> <li>- Tire conversion kits (studs) are also eligible.</li> </ul>	\$40/studded tire OR \$40/bike (conversion kit)	
Walking aids <i>(winter only)</i>	<ul style="list-style-type: none"> <li>- Receipts must be dated between Oct 1 and Mar 31</li> <li>- Yaktrax, IceTrekks, or similar. Mountaineering-style crampons and boot conversion kits are <u>not</u> eligible.</li> </ul>	\$20/pair
